2. I understand that the Showcase will include running; sliding into bases; throwing, fielding, catching, and hitting baseballs; and all of the other physical movements and activities commonly associated with baseball. I believe Player is physically capable of participating in the Showcase.
3. I UNDERSTAND THAT BASEBALL IS A STRENUOUS AND POTENTIALLY DANGEROUS ACTIVITY. I understand and acknowledge that participation in the Showcase activities entails the risk of personal injury, including, but not limited to the following: strained or sprained muscles, tendons, or ligaments; bone fractures; heat exhaustion; dehydration; contusions or lacerations of the skin; concussions; head and back injuries; cardiovascular trauma; and, in the worst case, death.
4. Player wishes to participate in the Showcase, and Player and I accept and assume the risks relating to such participation.
5. I understand the possible risks and dangers relating to participation in the Showcase. No promises or guarantees have been made to me or Player in this regard by Lincoln College or others who may be associated with the program/activity.
6. I understand and agree that I am responsible for arranging for Player's own health, accident and liability insurance.
7. I agree to hold Lincoln College harmless from any injury arising from Player's participation in the baseball camp whether the injury is caused by the College's own negligence, faulty equipment or otherwise.

In consideration of participation in the Showcase, I for myself and Player hereby release, remise and forever discharge Lincoln College of and from all liability, claims, actions and possible causes of action whatsoever that may accrue to me or to Player from every loss, damage and injury, including death, that may be sustained by the person and property of Player arising out of, or connected with, participation in the above-described Showcase.
9. This Waiver and Release shall be governed by Illinois law and any action related to the enforceability of this document will be brought in Logan County, Illinois.
10. The terms of this document are binding on the one signing the document, the Player, and their spouse, heirs, assigns and personal representatives.
